### **Our Impact**

The inaugural WEE Forum was held on October 24, 2023, at Mestil Hotel in Kampala, Uganda. This landmark event brought together 97 delegates, a diverse cross-section of stakeholders that included CEOs of UBA Member Supervised Financial Institutions (SFIs), FinTechs and representatives from government, NGOs, and the private sector.

Key discussions at the forum revolved around various barriers affecting women's economic empowerment, including:

- Social norms and gender bias around professional growth and ownership of resources
- · Lack of access to affordable finance
- Unequal contributions to unpaid care work at home

The forum concluded with the official launch of the UBA Women Economic Empowerment Initiative by the Minister of Gender, Labour and Social Development.


